## Talking to Taira: an Interview with the President

As 2020 drew to a close, MGCI welcomed its new Student Activity Council (SAC). The Reckoner sat down with SAC President Taira Mehta to discuss her plans for the upcoming year.

Taira obtained her position by default, as she was the only candidate to run for President. She said that the main reason she wanted to run was that she "loved the idea of being able to guide the council in such unprecedented times." She continued to say, "I want to make sure that 2021, for everyone in this school, is something that we look back on and love. I think that especially in a time and period like high school where people are trying to figure themselves out, if you throw COVID in there, people have a really hard time connecting with each other. So that's the job of the student council, to help connect people and make them feel like they're a part of something larger than just themselves, part of a school community."

Taira's presidency itself is also unprecedented: she is the first Grade 11 student to ever serve in this position. Despite being younger than previous presidents, Taira is confident that she has the abilities required for the role. "I don't think my age has anything to do with my competency, I also have the ability to figure things out quickly. My experience on student council outshines the fact that I'm in Grade 11," she said.

Her experience on SAC can speak for itself. During the 2019-2020 school year, Taira served as the Social Convenor and was responsible for organizing our Winter Wonderland dance. She had also hoped to introduce grade lounges, but her plans were cut short due to the pandemic. Since our SAC elections were delayed until December, she was also part of the interim council last as the Spirit and Social Convenor. In this role, she hosted spirit events including Among Us tournaments and a gratitude initiative on Instagram.

In terms of how she plans to lead, Taira said that, "a lot of people think that student council is some sort of hierarchy, but I like to think of it differently. I like to think that I basically am an assistant there to inspire innovation and new ideas based on the visions that the rest of my council have, and I'm there to accommodate that." She aims to focus on change and innovation, and is encouraging her fellow SAC members to try out all their craziest ideas.

They've already started to make changes by creating junior and senior roles in the place of single positions. Taira hopes this will allow younger students to have more of a voice on SAC, which has been historically dominated by older students.

One of Taira's proposed initiatives is online mental health spaces, where students can relax, spend time with their friends, and in her words, "vibe to music". She hopes to hold social events such as games nights and movie nights. SAC is also working on connecting with small businesses to supply school merchandise for Marc Garneau.

All events will be online this year, so expanding outreach is a major concern for Taira. She wants to make sure that SAC is able to communicate with the student body to inform them about the events that are taking place, as well as initiatives such as sweater sales. She encourages students to follow the SAC Instagram @mgci.sac to stay informed.

SAC meets weekly using Zoom, and will be posting meeting minutes and agendas once all positions have been selected. Taira anticipates that their work will be very fast-paced in order to make up for the time that was lost due to the election delays. She emphasized that her biggest goal is to not let COVID impact our spirit as a community.

Finally, Taira had a message for all students, an excerpt from her campaign speech which was never released: "Even though quarantine is changing our lives, it doesn't necessarily have to be for the worse. In fact I want you to give me the chance to make this the best year possible. It's true that this past year has been insane, but I think it's time to take back the memories and experiences that quarantine has stripped from us. As your SAC President, I'd be honoured if you let me make that a reality for our school. Stay safe Garneau. I can't wait to make great memories."



# Discovering Debating in Debate Club's Discord

What do models, POIs, table banging, case construction, and whipping have in common?

Here's a hint: it's not fashion, math, table misuse, architecture, or foamy cream. Rather, they are all elements of debate. Chances are, these words have been uttered multiple times in the Debate Club Discord server during their meetings on Mondays, Tuesdays, or Wednesdays. Members attend on different days, depending on their cohorts.

Marc Garneau's Debate Club was founded in 2018 by Grade 12 student Akil Miki Huang when he wanted to build up a robust debate team for MGCI. When asked about what inspired him to start the debate club, he said, "Talking with debaters at other institutions, I realized that we were behind on training and club opportunities. A couple friends and I decided we would set up a club, starting small and working our way up."

Contrary to the infamous televised debates, high school debate is civil, educational, and fun to watch. Students learn to think critically and analytically. They are encouraged to debate a wide scope of topics that range from regretting social norms to types of activism and even whether or not the opposition side has already won the debate. Through the numerous lessons and practice debates, club members have an opportunity to hone their skills of idea organization, collaboration, efficient note-taking, and public speaking. Furthermore, Debate Club is a community and a safety net for members to bond and feel supported.

As the president of the club, Akil said, "Our priorities at debate club are centered around the construction of a community at Garneau! Of course we value the oratorical skills and argument-building that debate often helps with, but we try to create a strong community bond and I offer whatever help I can—regardless of whether they're debate-related or not—to our members."

Debate Club meetings typically consist of lessons on new skills and practice rounds. Motions have ranged from those extracted out of recent high-school tournaments to fun, unique motions on challenging topics with unexpected formatting. Lessons teach important skills and techniques used in debate, such as argumentation, refutation, speech structuring, and more. Despite the argumentative nature of debate, Debate Club has a comfortable environment that encourages friendship and community. Debate Club member Lisa Zhang stated, "I wanted to join the club for a more laid back experience. I just enjoy being able to debate with friends and do interesting motions that I don't always get in debate class."

The experience of club members also varies, as everyone, regardless of skill level, is welcome in the club. Because levels range from new novice to seasoned se-

niors, Debate Club sorts members into "junior" and "senior" categories. Some people have joined to learn about debate with their schoolmates, while others use this opportunity for extra practice, like Carrie Jiang: "I joined debate club because I just started doing debate in the summer and I wanted to develop my skills within the school club, sort of like extra practice."

The Debate Club also sends several members to represent MGCI at tournaments. This year, tournaments are run online on a discord server. Most tournaments take place over a span of one-to-two days with multiple rounds each day, along with "break" rounds-the semifinals, finals, and junior finals. These tournaments include Upper Canada College's Pro-Am tournament, and coming up in 2021, two of Toronto's highly well-known high-school tournaments: Hart House HS 2021 and Western University's 2021 high school debate tournament.

Regarding the near future and coming years, Vice President Larissa Long said, "Honestly, I just want MGCI debate to remain an open and inclusive club where anyone can join and come to learn, make new friends, and joke around. I love the atmosphere that this year's debate club has fostered, and looking at how far we've come in these past few years is astounding."



#### Food For Families: Food Banks During COVID-19

Despite the numerous challenges of COVID-19, food banks around Toronto remain open to serve families in need. However, just like the communities they assist, food banks have also had to adapt to the pandemic. Many food banks, such as Flemingdon Park Food Bank and Community Share Food Bank, which was established in 2004, operate under reduced hours or have had to handle distribution with fewer volunteers.

"One of the biggest changes is that we've had to hire a part-time food program manager to oversee our operation," said Dorothy Boothroyd, one of the Co-Chairs of the Community Share Food Bank, which operates out of the Church of Ascension in the Don Mills area.

Before the pandemic, the food bank was managed by over one hundred volunteers who worked in rotations. Given current restrictions, only about thirty volunteers are available to work on a rotating basis. Volunteers wear masks while on duty, and wash their hands and change gloves frequently. Food is distributed behind plexiglass in pre-packed bags of perishable and non-perishable items. Furthermore, clients in need of food must make appointments through phone or email before arriving at the food bank. Distribution hours have been reduced to Wednesdays instead of Tuesdays and Saturdays.

Moreover, Community Share Food Bank, which operates under the umbrella organization North York Harvest, has had to roll back many of its programs due to the pandemic, including its popular nutritious breakfast program, which provided healthy food and opportunities to socialize.

Although need may be increasing in other areas of the city, Ms. Boothroyd said the demand for food has remained mostly static in the catchment area of the Community Share Food Bank. However, there is an increase in the number of food deliveries made to families. Before the pandemic, the food bank delivered food to approximately ten families each week, but now it delivers food to more than thirty-five families each week in collaboration with Better Living, which runs a Meals on Wheels program.

When asked about the qualifications needed to obtain food, Ms. Boothroyd said, "There's only one qualification, and that's that you live within the catchment area." There had been additional requirements based on financial criteria three to four years ago, but "nobody comes to a food bank who doesn't need to be here," she said. However, if a client resides outside of the catchment area, they will still receive food, but will be referred to the food bank in their area.

Due to the pandemic, Community Share Food Bank has not run any food drives, but it has been running a successful 'no-food' food drive by accepting monetary donations through its website. The donated funds are used to purchase produce, milk, and eggs to enhance what is regularly received from North York Harvest and Second Harvest for families in need. The food bank has a strict healthy food policy that strives to procure

perishable and non-perishable items composed of non-processed foods, low in sodium and sugar. Although the food bank does accept donations of healthy food at this time, it must be contacted in advance and food donations must be isolated for ten days before they can be distributed.

Apart from donations of food or money, raising awareness about food banks and the need for food banks is important for food banks to continue operating. Students had previously volunteered at Community Share Food Bank, but under these circumstances, no student volunteers are allowed.

Furthermore, Ms. Boothroyd suggested other resources for youth, adults, and seniors, including Kids Help Phone [1], Toronto Seniors Helpline [2], What's Up? [3], and a guide to coping during COVID-19 from North York General Hospital [4].

"Stay hopeful. We have to obey municipal, provincial, and federal guidelines to stay safe. If we work together, we can get through this," Ms. Boothroyd concluded. "Continue to reach out to people via Zoom and other platforms. Try to laugh, get exercise, stay as well-nourished as your circumstances allow, and avail yourself of food banks as necessary."

"Until the end of days."

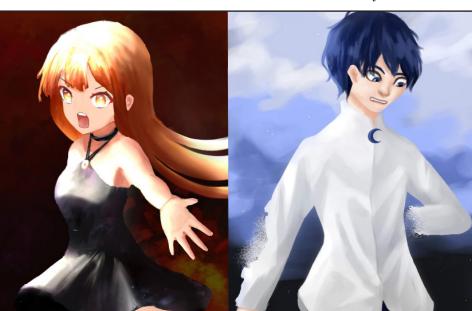

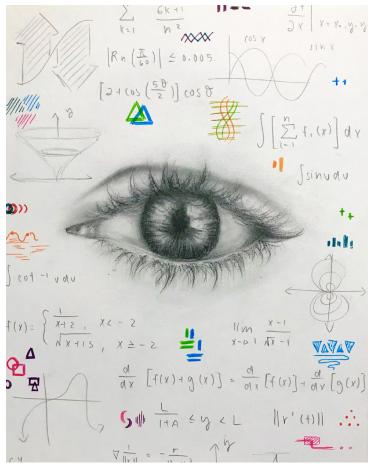

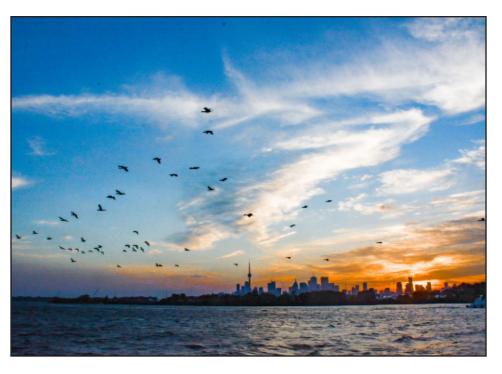
The sky is white. It should be beautiful, heavenly even, but really it's awfully cloudy.

## Should Transgender Teens Require Parental Permission to Transition?

Last month, a B.C. court ruled in favour of a 17 year old's mother who filed a lawsuit after she discovered that her child was planning on undergoing a mastectomy—a surgery that removes breast tissue-and was already obtaining prescription testosterone without the mother's permission. The mother has made repeated statements that her child was caught up in a "fad," and went on to state that what "anxiety-ridden girls really need is psychiatric care." On 5 November 2020, one day before the scheduled operation, Justice Shelley C. Fitzpatrick granted an injunction preventing Dr. Daniel Mckee from performing surgery or even providing counsel to the teenager [1].

The vast majority of parents want the best for their children, making it quite understandable for a parent to be unsure whether or not an irreversible surgery with lifelong consequences is right for their child. However, it is just as understandable for a person to want to feel more comfortable with their body, which is why parents absolutely need to educate themselves about gender identity to truly do what's best for their child.

Contrary to belief, being transgender is not just a "fad" that will go away. It's very unlikely this particular teenager woke up one morning, decided they didn't like their gender, and decided they wanted to undergo a major, life-changing surgery. Whether one likes it or not, gender affects so many aspects of one's life - from appearance, to how one is expected to behave socially, to how other people think of a particular person. No one would casually change something that is such a large part of their life. People often take years, even decades, to figure out where they lie on the gender spectrum. In fact, in B.C., at least one assessment and letter of recommendation from a qualified professional is required to perform any gender reassignment surgery [2]. During the assessment, a number of things are thoroughly evaluated, including whether or not the patient has gender dysphoria, whether or not they are in a good state of mind, and what effects surgery would have on their mental health to ensure that the transition is as smooth as possible.

It's been said and proven on many occasions and by numerous professionals that teenagers are more impulsive and make decisions more spontaneously than people of other age groups [3]. However, it would be wrong to assume that adolescents have poor decision-making skills with respect to every choice they make, and to dismiss said choices. Many say that teenagers who seem to suddenly decide they are transgender are only being impulsive, without realizing that they have probably been considering this for years. Chances are they are secretive with their identity out of fear of people's reactions, as is the case with anyone coming out to reveal their non-normative identity. Then, when they finally decide to take action after years of secretly questioning, they're accused of being misled by the media and not knowing themselves. While they may be told these things out of concern, it mostly comes across as invalidating their identity.

Not only that, but denying people the right to transition can be detrimental to their mental health, no matter how old they are. The problems often start when they realize they feel stuck in their bodies. They then worsen when people assume their desire to transition is an impulsive decision resulting from their mental health problems, which were in fact a result of their desire, and inability, to transition. A survey done by The Trevor Project

showed that more than half of transgender respondents seriously considered suicide at some point in their lives [4]. This rate is concerningly high, and denying them the right to be comfortable with such a large part of their identity, all because their parents think they know their children better than their children know themselves, is not helping the situation. On the other hand, studies find that the vast majority of transgender people are much happier after transitioning [5].

Last but not least, the more people progress through puberty, the harder it is for them to transition. As their body develops,

the more they look like a gender that they do not identify as, and therefore, the more they may be exposed to gender dysphoria, harassment, and discrimination. Many surgeries are best done before the body is fully developed, including mastectomies, which may cause significant scarring if done on mature breasts [6].

Overall, it should be up to teenagers and qualified professionals to decide whether or not to undergo gender reassignment surgery. Teenagers still have so many years of youth, and they deserve to live them happily, without being obstructed by whatever view the outside world has of them.

## Snowden: Vindicated by History

In June 2013, yet another mysterious three-letter organisation entered our collective consciousness. Unlike other famous organisations like the CIA, FBI, KGB, and CDC, the National Security Agency (NSA)'s sudden prominence was not due to movie directors looking for a quick buck. Instead, it became a household name after contractor Edward Snowden leaked classified information on mass surveillance programs to the world on the front pages of *The Guardian* and *The* Washington Post [1]. So who was Edward Snowden, what did he do, and why should we care now?

We live in a society. This means that although we have certain inherent rights and freedoms, reasonable restrictions sometimes need to be placed on them-hate speech laws, building codes, and speed limits are good examples of this. Furthermore, most people believe that the restrictions need to be proportionate, and normal people going about their daily lives should not be troubled by them. However, it was generally accepted by those working for the NSA the US's digital surveillance agencv-that covert, indiscriminate, oversight-less, Orwellian mass surveillance was justified. Mass surveillance of not just US citizens, but the entire world [2].

Looking at his initial career choice, most people wouldn't expect Snowden to later be branded as a traitor. He was a young, patriotic special forces trainee who left the army only after both his legs were broken. He then signed on with the CIA as a computer specialist but resigned shortly after because of moral objections. After that, he worked as a contractor for the NSA through Dell. There he conducted

research on China's mass surveillance, but soon became concerned that the US was engaging in the same behaviour on a much larger scale. Around this time, he began to raise concerns through official channels—concerns that went completely unheard. He then began downloading files, determined to reveal the NSA's actions to the world [3].

In March 2013, James Clapper, who was in charge of overseeing the NSA, testified under oath that the NSA did not collect any data at all from Americans [4]. For Snowden, this was the last straw. He immediately quit his job at Dell and found another consulting job, where he could gather more evidence to expose the NSA. Two months later, he was on a plane to Hong Kong under the pretext of getting medical treatment. There, he met with several experienced journalists he had previously contacted over the internet, and fled to Russia shortly after [3]. The subsequent revelations, as we now know, were unprecedented.

The world now knows that overstating the extent of the NSA's snooping is near-impossible. Through a combination of international partners (primarily Australia, Canada, New Zealand, and the United Kingdom), willingly cooperating companies, court orders, and hacking, the NSA collects all types of communications, industrial secrets, financial information, location information, internet ac-

tivity—everything. Even though you would expect Americans to be the primary targets of American surveillance agencies, foreign citizens were targeted en masse due to their lack of protection under the US Constitution—in some countries, every phone call was recorded. Americans, Canadians, activists, companies, governments no one was immune [5][6]. In a leaked document, the NSA listed its goals to "Collect it All," "Process it All", "Exploit it All", "Partner it All", "Sniff it All", and eventually to "Know it All" [7].

On top of it all, the NSA had also developed numerous hacking tools to help them illegally break into systems, and a search engine called XKeyscore that allowed them to browse through someone's entire digital presence—every analyst had the power to use or misuse this [8]. Some parts of the surveillance were legal—enabled by the infamous PATRIOT Act-and some were of questionable legality, but the vast majority of it was unquestionably illegal, unconstitutional, and in violation of international law [5][15]. The most important part was that it was unknown and unaccountable to the public. The only provisions for oversight were James Clapper—who we have already met above—and a rubber-stamp court that approved over 99% of requests [9]. Surely government officials would have thanked Snowden for doing his duty to "support and defend the Constitution"?

It's often necessary to break an unjust law to bring attention to an issue and eventually create change—people in history who have done this include Oskar Schindler, Rosa Parks, and Martin Luther King, Jr. Even though they were initially controversial, we now recognise that they were completely justified and wonder why none of their contemporaries did the same. We have a moral duty to refuse to obey unjust laws, as well as to speak out when we discover

abuses of power—whether by the government or some other authority. Unlike other NSA employees who felt they should be above the law or were intimidated into silence, Snowden spoke out at great personal risk to himself.

And it's important to stress the full extent of the risk-the first charges brought against him carried a combined prison sentence of thirty years, and more charges were expected. He would be on the run from the most powerful country and intelligence agencies on the planet. In an anonymous interview, many powerful government officials fantasized about personally murdering him [12]. He expressed it best himself, saying "Everyone in the Intelligence Community is aware of what happens to people who report concerns about unlawful but authorized operations" [13]. We may not all have spoken out under the same circumstances, but we can support Edward Snowden and recognise him for what he is definitely not a traitor, but a hero to all of us.

Snowden has many critics, but many of the arguments against what he did purposely misrepresent the facts or are based on misconceptions. The most common argument is that he should return to the US and stand trial: that the justice system is just, and he should plead his case to a judge and jury. This argument overlooks the fact that he is charged under the Espionage Act, a relic from history that effectively stops the accused from defending themselves—in previous cases, whistleblowers were not allowed to explain their rationale or to mention the word "whistleblowing" [11].

Another argument is that the documents he took were not limited to those about mass surveillance, and Snowden intended to deliver the documents to Russia. He did take documents unrelated to mass surveillance, but he needed them to prove his credibility—

without them, he would just be another conspiracy theorist. Additionally, only a few documents related to mass surveillance have been released after being checked over by journalists—the remaining ones are safely encrypted. The final common argument is that the information Snowden leaked harmed national security and helped terrorists—the US Congress was kind enough to release a report with twenty-one examples of how the information harmed national security, but they were all blacked out [14]. As for the terrorists, the NSA could only cite one example that was later found to be unrelated by a judge [15].

After the revelations, there were protests and petitions—including many in Canada—demanding governments end illegal mass surveillance and cut ties with the NSA. World governments—including Canada—took swift action. Specifically, they legalised the surveillance after the public attention had died down [16]. Here in Canada, Bill C-51 gave CSIS (our intelligence agency) sweeping new powers [17].

Canadians often take pride in Canada's [objective] superiority to America. It's tempting to dismiss the NSA as an American problem and trust our government to respect our privacy. The truth is far more unsettling. The Canadian equivalent to the NSA is called the CSE, and it has even less oversight than the NSA—it's regularly found to be violating our rights, and also helps the NSA around the world [18]. The Bill C-51 that I mentioned above was the Canadian equivalent to the PATRIOT Act, trading away our rights for "national security"  $\lceil 17 \rceil$ .

But it doesn't have to be this way. We live in a democratic society, and there are countless ways we can fight back against the ongoing erosion of our rights. Write an email—or a letter that can't be intercepted—to your Member of Parliament [19]. Find and attend protests against mass surveillance. Learn how to protect your digital privacy [20]. Support charities like the Electronic Frontier Foundation and the Canadian Civil Liberties Association. Learn about where the political parties stand on these issues and vote when you're able to. Above all, stay informed about the issues that affect us all—through The Reckoner.
